Series 5 — Beyond Our Shores

Session 1: Friday 21st July 2023

Presenter: *Dr Maria Pozza*"Space Law"



Dr Pozza's expertise in space law has been called upon by a number of domestic and overseas and agencies, domestic and international institutions, research institutions, and legislative development committees. Her work experience is vast and includes litigation, arbitration, corporate and commercial domestic laws, and international law. Her client portfolio is wide ranging reflecting a cross section of entities.

Dr Pozza is often invited to speak at national and international conferences concerning space and cybersecurity.

Session 2: Friday 28th July 2023

Presenter: David Turner

"Risk Management at a Corporate and Government Level"



David Turner CEO RiskNZ is a senior business executive and trusted advisor with over 20 years' experience in the risk management industry.

After the military, he contracted to various private and government organisations in leadership, risk and project roles, and opened his own company which advised on risk management and provided personnel for major projects including; BHPB, Rio Tinto, Multiplex, Police, Australian Elections, and also CHOGM 2011 working with State and Federal Police.

David was born in NZ and returned in 2016 to work on the Transdev Wellington rail network transition. He now lives in New Zealand permanently and has worked with Deloitte, KPMG, Defence, MOJ and PwC. He brings a unique blend of expertise across diverse areas with a focus on risk management of human behaviour – one of the more complex, dynamic and often over-looked areas of the industry.

Session 3: Friday 4th August 2023

Presenter: Joanna Mossop

"Can International Law save the High Seas"

In March, states finished negotiating a new treaty for the conservation and sustainable use of marine biodiversity in areas beyond national jurisdiction (the high seas and deep seabed). This talk will cover how the oceans are managed under international law, what are the challenges to sustainably managing human activities on the high seas, and how the new treaty might (or might not) contribute to a better ocean future.

She has worked with the New Zealand government and the United Nations Development Programme on law of the sea issues, and in 2019 the New Zealand government nominated her to a list of arbitrators and conciliators under the United Nations Convention on the Law of the Sea.

Session 4: Friday 11th August 2023

Presenter: Glenys Karran

"New Zealands Relationship with Europe"

Glenys is a born and bred Invercargill "girl", who attended James Hargest High School and then studied sciences at Otago University before joining the Ministry of Foreign Affairs and Trade in 1994. Over the years, she has worked on a variety of foreign policy topics from nuclear disarmament to managing aid programs in the Pacific. Glenys speaks Japanese and was posted to Japan (many years ago), and more recently was an Ambassador's wife in Pretoria, South Africa. She is currently a Manager in the Ministry's Europe Division responsible for New Zealand's relationships with the European Union and its Member States.

The Ministry of Foreign Affairs and Trade is the government department responsible for managing New Zealand's relationships with other countries and international organisations like the United Nations. Glenys will tell us how they go about delivering on the government's foreign policy priorities, with a particular focus on NZ's relationship with the European Union and its Member States.
